Thanks to your enthusiasm, generosity, and support, we hit the ground running in 2017, providing 355 lessons to individuals with special needs and disabilities within our first year of operation. With the assistance of six program horses and over 1,000 volunteer hours, our PATH Certified Instructor Micah Keshemberg conducted 225 lessons of therapeutic riding, 68 lessons of equine-assisted activities and therapies (EAAT Education), and 62 lessons within our Equine Services for Heroes program. Needless to say, we could not be more proud of what we have been able to accomplish together, and we are excited to keep growing in 2018.

Year one has taught us many valuable life lessons as well, such as the positive and lasting impact one life can have on so many. Andy looked forward to being around horses again since he and Colleen formerly owned and showed their miniature named Picasso.

Unfortunately, while battling Parkinson's Disease, Andy developed an idle tremor; however, he never let it hinder his humor around the ranch or his determination to ride. He particularly enjoyed grooming and feeding the horses at Heaven's Gait Ranch as the tasks enabled him to attend to their needs while also calming his own. By fall 2017, Andy was proud to ride Jack and Mac, ending each lesson with a beaming smile, sincere "thank you," and gentle reminder to "make sure the horses always have carrots."

Sadly, Andy took a break from riding over the holidays and passed away in January 2018. Our program horses and staff deeply miss him, so to keep his spirit of kindness and positivity alive at Heaven's Gait Ranch, we will be launching the Andy Mueller Memorial Scholarship this year, which offers assistance to individuals with special needs or disabilities who are interested in our therapeutic riding program but have demonstrated financial need that hinders their ability to participate.
